Day by Day Itinerary

Sun., Aug. 16 – FAIRFIELD GLADE / VANCOUVER

This morning we depart Fairfield Glade by private motorcoach and travel to Nashville International Airport as we take to the skies for Vancouver, British Columbia. Lying between the Coast Mountain range and the Pacific Ocean, Vancouver is one of the most scenic cities in the world.

Mon., Aug. 17 – VANCOUVER

This morning we'll see the highlights of Vancouver's varied urban scenes on an introductory city tour. We'll see the city's iconic sights and neighborhoods including Chinatown and Gastown, the historic original downtown core where Vancouver began. Then we're headed to Stanley Park, a rare urban wilderness occupying 1,000 acres just north of downtown; it is a flourishing example of how Vancouver balances nature with its urban identity. Next, we're headed to Granville Island, a magical escape within the city that is home to a vibrant arts scene and home to the ever-popular Public Market. (B)

Tues., Aug. 18 – VANCOUVER / KAMLOOPS

Today we depart Vancouver aboard the Rocky Mountaineer on the route known as the Journey Through the Clouds line. Leaving Vancouver, our rail journey will take us from the coastal city of Vancouver to Kamloops, in the heart of British Columbia's interior. We'll travel through the fertile farmland of the Fraser Valley before entering the forests and river canyons surrounded by the peaks of the Coast and Cascade Mountains. Along the way, the train will slow so that we can fully appreciate Hell's Gate, a must-see while traveling through Fraser Canyon. The landscape undergoes another transformation as we follow the Thompson River through scrub brush and desert to historic Kamloops. Known as the "meeting place" of the North and South Thompson rivers, we'll experience an unhurried lifestyle and warm hospitality in this friendly town that basks in over 2,000 hours of sunshine per year. Wed., Aug. 19 – KAMLOOPS / JASPER

On today's *Journey Through the Clouds*, we will once again be surrounded by dramatic scenery as we follow the banks of the North Thompson River through the Monashee and Cariboo Mountains, climbing ever nearer to the high peaks of the Continental Divide. One of the highlights of today's rail journey is Pyramid Falls.



Cascading in two dramatic drops totaling 300 feet, we'll have an up-close view of the drama of the falls flowing under the tracks before joining the rushing North Thompson River. Then we'll traverse the Yellowhead Pass into Jasper National Park, as we rail past teal-green lakes closing in on Mount Robson, the tallest peak in the Canadian Rockies. The scenery continues to unfold outside our windows on our way to the self-described little town of Jasper. (B,L)



Thurs., Aug. 20 – JASPER

Located in the heart of Jasper National Park, a UNESCO World Heritage Site, we'll soon find out that Jasper offers unlimited activities both day and night. A day of leisure in this quintessential mountain town nestled on the Athabasca River will allow you to experience the park's natural beauty through your own pursuits or to simply enjoy the town of Jasper itself given its' bustling shops, galleries, cafes, with spectacular views in every direction. Fri., Aug. 21 – JASPER / BANFF

Today we depart Jasper for an exciting day on tour that will introduce us to the Columbia Icefield, located on the boundary of Jasper and Banff National Parks. On arrival at the Columbia Icefield Glacier Discovery Centre we'll board the massive Ice Explorer vehicle that will take us on an excursion to the surface of the Athabasca Glacier. After lunch, we'll take part in an interactive learning experience in the Glacier Gallery Exhibit, a self-guided tour to discover how a glacier moves, highlighting the importance of icefields in climate research. We'll also discover the Glacier Skywalk to capture a feeling of absolute wonder at the edge of the Sunwapta Valley. Following our visit, we'll travel the Icefields Parkway on our journey to Banff, the best known of the Canadian Rockies' national parks, and Canada's first. (B,L)

Sat., Aug. 22 – BANFF

The day is at leisure for independent sightseeing. The town of Banff is only four-square kilometers, bordered on all sides by wilderness, so it's not uncommon to see wildlife, such as deer and elk, in backyards! The town is a service center for Banff National Park visitors and offers everything from museums and galleries, shopping, plus a long line up of outdoor activities. Whatever you choose to do, Banff will have something for everyone! (B)



Sun., Aug. 23 – BANFF / CALGARY


Today we depart Banff and travel to the bustling city of Calgary.
